- (iii) CAMS Licence application forms are separate to this membership form and must be completed as per instructions. Licence payments can be made directly to CAMS, or to HSCCQ.
- (iv) Concessional Registration Membership is for members requiring membership only to acquire documentation to register their vehicle under Historic Registration and will not be participating in any CAMS events organised by us or any other clubs, this membership must be continuous while the member has the vehicle on Historic Registration as Qld Transport may require confirmation of membership at any time.
